Meeting Opened

Board President Cummings called the meeting to order at 8:01 p.m.

Recognition of Visitors

Board President Cummings welcomed the visitors. New Business

Presentation to Outgoing Board President Mr. Lawrence Trogel

Board President Cummings stated that it was a privilege and pleasure to recognize the service of Trustee Trogel as the outgoing School Board President. Trustee Trogel was presented with a plaque that read “With recognition and gratitude for your devoted service to the children and the community of the Valley Stream Central High School District.”

School Board Visits Resolution

Superintendent's Report

Request to Accept Gift

On motion of Trustee Jacobs, seconded by Trustee Trogel and carried unanimously, the Board approved to accept a donation from the South Nassau Lodge, Knights of Pythias, in the amount of \$125.00 to be used in the Performing Arts program at Central High School.

Information and Exploration

Dr. Bernstein introduced the new Assistant Principal for Central High School, Jacques Blain, to the Board and community.

ASE Program Open Questions

After the August 31, 2010 Board Meeting, there were 2 open questions regarding the ASE program.

I) What schools are the current ASE students zoned for?

Five students are zoned for South High School, four students are zoned for North High School and three students are zoned for Central High School.

II) What is the age distribution of the current ASE students?

The age distribution has one student at the youngest point of 14 years old and one student at the oldest point of 20 years old with the other students dispersed in between. Dr. Bernstein explained that the ages would be as of June, 2011.

Trustee Jacobs asked how the Special Education programs were distributed across the District? Dr. Bernstein responded that inclusion classes and resource room were in all the buildings while some of the smaller Special Education programs were in individual buildings

Summer School Report

Dr. Tracey Nekulak presented a report regarding the Summer School Program.

Summer Music had 674 students, grades 3 – 12 for all of the Valley Stream students. This was a decrease of about 120 students from last summer which could be because of the tuition increase.

This was the 58th year of the Valley Stream Central High School District sponsored Community Band. All performances brought out a large audience throughout the summer.

Driver Education had 102 students which was a decrease of about 37 students. The program was the same price as last summer.

The academic summer school program, under the leadership of Dr. Joseph Pompilio, that all fifteen summer school seniors completed their requirements and graduated on August 20, 2010.

The Jumpstart program, which identifies at risk incoming 7th graders, was in its 5th year with 35 students participating.

Dr. Nekulak stated that overall, this was a very successful Summer School Program and thanked the Board of Education for their continued support.

Dr. Bernstein requested of the Board that there be consideration whether to discontinue the Summer School graduation as there has been a decrease in the size of Summer School graduates. The Board can discuss that any summer school graduate have the option to attend the June graduation at their home school. If the Board wishes to discuss this, it should be done in the fall so that there is time to let the Policy Committee formulate the changes into policy.

The consensus of the Board was to agenda this item for discussion at either the October or November Committee meeting.

Trustee Chiachiere thanked the staff at all of the buildings as the decrease in summer school students is a compliment to the staff.

Opening Day of School

The Superintendent and Dr. Thomas Troisi visited all four buildings on the opening day of school which went fairly smoothly with few glitches.
