# **Meeting Opened**

Board President Cummings called the meeting to order at 7:00 p.m.

Dr. Heidenreich thanked the Board of Education for the confidence and that he looked forward to the challenges ahead and working with the students and community of the district.

The Board thanked Interim Superintendent of Schools, Dr. Richard Marsh, for keeping the district running smoothly for the last 6 months.

# Resignation of Assistant Superintendent of Personnel and Administration

On motion of Trustee Cummings, seconded by Trustee Iadevaio and carried unanimously, the Board hereby accepts the resignation of Dr. William Heidenreich from his position of Assistant Superintendent of Personnel and Administration effective June 30, 2011.

# **Appointment of Superintendent of Schools**

# Approval of Transfer of Funds from the Employee Benefit Accrued Liability Reserve

# Approval of Transfer of Funds to the Workers' Compensation Reserve Fund

On motion of Trustee Trogel, seconded by Trustee Jacobs and carried unanimously, the Board approved the Superintendent of Schools to transfer from Unappropriated Fund Balance 2010-11 an amount not to exceed \$500,000 from the General Fund to the Worker's Compensation Reserve Fund.

#### **Approval to Fund Retirement Contribution Reserve Fund**

On motion of Trustee Trogel, seconded by Trustee Jacobs and carried unanimously, the Board approved that in the event there are sufficient funds remaining in the 2010-11 budget, the Board shall cause the Retirement Contribution Reserve Fund to be funded in June, 2011, in amounts not to exceed \$1,500,000.
